PRIVACY POLICY CONSENT FORM

In light of the GPRD Regulations (RGPD (UE) 2016/679) ;

In light of Article 6 ;

I. Data Purpose.

1. Which personal data will be processed ?

II. Retention period and rights

1. Retention period

The data processed by the FIEA is based on an « active base » which means the data is often used by the services in charge.

Data will be erased at the end of the « active base » period

Your personal data will only be collected during your membership at the FIEA. Once you are no longer a member, the data can be erased. For administration purpose, the FIEA may hold onto the data for up to 5 years.

2. Right to access, rectification, to erasure, to restrict processing, to object processing, to data portability

Article 6 – Lawfulness of processing

1. Processing shall be lawful only if and to the extent that at least one of the following applies: the data subject has given consent to the processing of his or her personal data for one or more specific purpose ;

Article 7 – Conditions for consent

1. The data subject shall have the right to withdraw his or her consent at any time. ²The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. ³Prior to giving consent, the data subject shall be informed thereof. ⁴It shall be as easy to withdraw as to give consent
2. When assessing whether consent is freely given, utmost account shall be taken of whether, *inter alia*, the performance of a contract, including the provision of a service, is conditional on consent to the processing of personal data that is not necessary for the performance of that contract.
